- ★ Completed vendor application/contract, which is attached along with a Check or Money Order made payable to the **Kinsmen Club of Brantford** or e-Transfer for <u>vendor fees</u> & may need a <u>seperate damage deposit</u> check, returned to address listed on application form. **Post dated checks will not be accepted**. A \$45.00 charge will apply to all NSF checks.
- ★ The signed PARTICIPANT RELEASE WAIVER FORM which is attached. *The Ribfest Committee may require liability insurance depending on product and risk* which would be a certificate of insurance with **Kinsmen Club of Brantford** & **Corporation of City of Brantford** added as additionally insured from an insurance company.
- ★ Tents occupying an area greater than 60m2(650ft2) or 20'x30' may also require a tent permit. If you would like to inquire and obtain a permit, please contact City of Brantford Building Department at (519) 759-4150.
